Bagged fertilisers should be stored under cover and out of direct sunlight (which degrades woven polypropylene packs). If stored in the open, do so for short periods only, and cover with a tarpaulin. If stacking is necessary, bulk bags should be stored in a stable manner, preferably in a pyramidal style. Bulk bags should not be stacked more than two high for bags containing 1000 kg or more, or more than four high for bags containing up to 500 kg. The Pallet Capacity Rating (design weight) should not be exceeded on the bottom tier for other packs. High stacking should be avoided as pressure promotes caking. Store away from farm chemicals, e.g. insecticides, fungicides and herbicides.
