Bulk bags should not be stacked more than two high for bags containing 1 000 kg or more, or more than four high for bags containing up to 500 kg. The Pallet Capacity Rating (design weight) should not be exceeded on the bottom tier for other packs. High stacking should be avoided as pressure promotes caking. Store away from farm chemicals, e.g. insecticides, fungicides and herbicides.
