12.2 Persistence and degradability

Biodegradable organic substance which may require a Biochemical Oxygen Demand.
In general, the plant extract appear to be biodegradable with a low environmental impact (for Algaefert solid K+, > 60% of biodegradation is reached within 17 days). The degradation products are naturally occurring elements.

12.3 Bioaccumulative potential

The product is very soluble in water and logKow is negative, therefore a low potential for bioaccumulation or bioconcentration is expected.

12.4 Mobility in soil

The product is very soluble in water, therefore it is not expected to adsorb to the sediment.

12.5 Other adverse effects

Plant nutrients may be beneficial to plants at low levels, however high levels may cause reduced growth or burns in sensitive species. Excess may be washed through soil to waterways. Nutrients released to waterways may cause algal blooms, with potential for toxic effects on aquatic organisms.
